FOOD VENDOR RULES & REGULATIONS

1. Standard food space rental is a flat fee of \$100.00 for food vendors. If you wish to lock in your spot, the fee must be paid by May 4th.
2. Your space should be left as clean as when you set up. Electricity and water will be provided if requested.
3. This will be a strictly cash only festival. Please make sure you have enough change for the weekend.
4. Entry in the exhibit constitutes an automatic waiver of any claim for damages, loss against the sponsor, any employee, volunteer, or representative thereof. Both parties agree that in the event of rain or other circumstances beyond the control of man, a refund will not be given.
5. Space allotted for the \$100.00 fee is 15' deep, and 12' wide. If you require more space than that, you will need to purchase an additional "spot." This also only allots for only 1(one) 50 amp electric hookup. If you need more, the charge will be \$20 per extra 10amps.
6. We will try very hard NOT to duplicate main entrees. There will be duplications of drinks and small items, I am sure. We cannot guarantee that there will be not duplications but we will try our best and appreciate your cooperation and understanding with this matter.
7. All vendors will be able to sell water, coke products and pepsi products.
